# A.S. in Accounting for Forensic Accounting leading to the B.S. in Fraud Examination <br> and Financial Forensics at the John Jay College of Criminal Justice 

Catalog Year 2022-23

The dual/joint degree program in Accounting for Forensic Accounting between Queensborough Community College and John Jay College of Criminal Justice is a jointly registered, dual-admission program that offers students a curriculum including principles of accounting, finance, and law, along with investigation techniques, ethics, and theories of criminology and the educational foundation to succeed in the forensic accounting field. Students who complete this A.S. degree may transfer to John Jay and complete a B.S. degree in Fraud Examination and Financial Forensics in 2 years. Please see your advisor for more information.

The number of credits you take each year will determine when you graduate. To graduate on time, you are strongly encouraged to enroll in at least 30 credits toward your degree during the calendar year, including fall and spring semesters and winter and summer sessions. This Degree Pathway is designed for students who place into MA119. Additional Degree Pathways are available for students who place into Pre-Calculus and developmental math. 1. Prerequisites for a course must be passed before taking the course. Corequisites must be passed before taking the course or taken in the same term as the course.
2. Students are required to take particular courses in some areas of the Common Core that fulfill both general education and major requirements. If students do not take the required courses in the Common Core, they will have to take additional credits to complete their degree requirements. The core mathematics requirement for this program is MA-128 or MA 260 or MA-440. Students who need to take pre-requisite courses (MA 114 or MA 119 and 121) will need to take additional credits.
3. This course is not required for students who take a 4 -credit STEM variant course in Required Core 1C.

All students must complete two (2) WI designated classes to fulfill degree requirements.
