Narrative summary of committee work

The bookstore and the college have a contract regarding the donation of textbooks. A few years ago the bookstore raised the amount that they would donate to \$15000. The library supplements this donation by buying extra copies of popular textbooks. The year before last (2009-2010) CUNY Central gave all CUNY libraries extra funding for textbooks and ebooks. Unfortunately they did not offer the funding for 2010-2011.

As part of the future role of emerging technologies used in the library, 2 Librarians now carry I-Pads to increase accessibility to students. Currently, the library reports 80% of journals and approximately 30% of books are available on-line. The library website now offers an “Ask the Librarian” feature which enables students to talk with a librarian electronically from off-campus. However, currently this feature is limited, due to lack of funding for additional hours.

Addendum 10/7/11 as per Professor Galvin: If funding permits, we may join a consortium to offer virtual reference for more hours.

Hours of operation continue to be an issue for many students, especially those who take courses on Sundays. This came up as faculty on this committee teach weekend courses, and students have discussed this issue. To address this issue, Professor Galvin will investigate the feasibility of operating the library on Sundays.

Securing space for students to work continues to be an issue. the library at QCC is open to the public (whereas other CUNY libraries require a CUNY ID to enter). It has been noted that many students from neighboring Cardoza High School loiter in the library. The librarians and security ask students who are using the library to socialize to move to the Student Union.

The committee discussed the possibility of having a volunteer student advocate work to assist other students with their research in the library. This would be beneficial for students who are looking to add

service learning to their developing e-portfolios, as well as serve as role models to other students, and offer assistance to the librarians. Professor Galvin will solicit feedback on this idea from other library staff.
