Business:

The meeting was called to order at 9:30 am.

- I. Anthony Davis, Director of Admissions addressed the committee:
 - a. In regards to students who are applying to be re-admitted with WUs on their transcripts based on mental health issues, Mr. Davis stated that these applications would be better suited to be forwarded to the office of Registrar. He explained that since these students need to appeal WUs, the office that processes these WUs should be the office that houses it. Then Registrar should forward these applications to the Counseling Center. Mr. Davis stated that he would speak to Ms. Farrat (Registrar Assistant) to review this process.
 - b. Re-admit applications that concern violence, will be directed to Mr. Davis who will handle these applicants in consultation with Dean Kerr (Dean of Students).
 - c. A question was raised about seeing student's prior decisions from the Committee on Course and Standing. Ms. Guzman requested to have access to Transcript Text on CUNY First which is what the Committee on Course and Standing use to document their decisions on each applicant. Mr. Davis stated that he will request Transcript Text access for Ms. Guzman.
- II. Discussion among committee members:
 - a. Dr. Dahlke asked if committee members where available to attend the Retention Management Meeting as a representative of the Admissions Committee. These meetings are held every other Wednesday from 11 – 12. Dr. Dahlke will send an email to the committee members where members can write their names alongside meetings dates that they will be able to attend.

- b. Each committee is getting encouragement from the Committee on Committees to have a set meeting time. They are asking for a 3 4 hour block of time. We decided that for this coming spring semester it will be Thursdays at 2pm and that for the fall 2016 it will be Fridays at noon.
- c. Applicants that include mental health documentation as a reason for their dismissal (yet have no WU grade) will be reviewed by the counselor on the committee to ascertain the legitimacy of the documentation. Based on the legitimacy of the documentation (may involve a phone call to the mental health professional), the committee will then make a decision.
- d. It was suggested that the office of Registrar and Admissions meet to address the following concerns:
 - i. Closing the loop on applications
 - ii. Provide shared platform to show where documents are pending or decisions are pending
 - iii. Provide a cover page that identify the process of the application especially when the application is being processed by 3 offices.
 - iv. Consider an electronic platform where we can go paperless and be more efficient.
