## 1. Committee Vacancies Reported via E-Mail on October 12'2004.

- a. Dr. Gerson reported that Reuvain Zahavy (Math), a fellow member of the Committee on Committees, has voluntarily relinquished his position on the Committee on Awards and Scholarships, thus enabling another member of the faculty to serve. The remaining members of the Committee are Caf Dowlah (Social Sciences) and Jenny Lin Martinez (Foreign Languages).
- b. Dr. Gerson also notified the membership that a member of the Committee on Course and Standing, Paul Gengo (Business), has a teaching schedule which conflicts with the Committee's usual meeting times. It was noted that Dr. Gengo was reluctant to show a discontinuity of service on his Curriculum Vitae but would be willing to step down from CCS should another opportunity to serve the College be available. No promises in this regard were offered.
- c. Dr. Gerson suggested to the COC that one possible solution for resolving the CCS problem might be to appoint Dr. Gengo to the Committee on Awards and Scholarships as a replacement for Revain Zahay. Dr. Gerson also suggested that Richard Mandel (Business) be appointed to the Committee on Standing to fill the position vacated by Paul Gengo.

d. Dr. Gerson distributed the latest version of the Committee Waiting List as an e-mail attachment and called for alternate suggestions or a motion.

#### 2. Motion Made and Seconded

- a. In a Reply to All on Oct 12<sup>th</sup>, Thorsen made the following motion:
  - To appoint Paul Gengo to the Committee on Awards and Scholarships replacing Reuvain Zahavy.

• To appoint Richard Mandel to the Committee on Course and Standing replacing Paul Gengo.

In a message restating Prof. Thorsen's motion, Dr. Gerson asked for a second to the motion.

- b. A message seconding the motion was received from Raji Subramaniam on Oct. 12<sup>th</sup> and distributed to the Committee on Oct. 13<sup>th</sup>.
- c. A period of time was set aside to allow for discussion. The comments posted were unanimously in support of the motion.
