- 3. Update on recertification: Jeff Hall: Several faculty members reached out over the summer concerning their recertification.  - c. Proposed language: At a subsequent date, the committee will propose a recertification process when faculty will periodically be requested for review of WI materials.

 - 1. Adjust language: "6) At least one exam could have a written component."
- iv. Discussion/Suggestion: Add CTAS visit to the Senate-approved syllabus statement
