Report of the President to the Academic Senate February 14, 2017

Enrollment Update

The College has concluded a busy spring enrollment cycle. As of February 2, we have enrolled close to 14,000 students. We exceeded our goal for new students, including 883 freshmen and 845 transfer students. Included in this newest cohort of freshmen are 111 students who successfully completed the CUNY Start and CLIP programs.

For the first time this cycle, incoming students who took the CUNY Assessment Tests at Queensborough and scored just below passing were invited to retest. 195 students were invited to re-test. 27 % or 53 students passed the CATs on the second try. The Office of Admissions is fully engaged on recruiting for Fall 2017, having already received our first group of freshmen applications for the Fall semester.

The Office of New Student Engagement, led by Dr. Carol Alleyne, held a most successful New Student Orientation on Saturday January 28th with over 500 students, parents, and other supporting family members in attendance. Faculty, staff, and Student Ambassadors helped to connect, engage, and inform new students to prepare them for their first semester at Queensborough. Alongside various support services at the College, their orientation activities concluded with "Welcome Week" - - an exciting line-up of events and activities during the first week of classes designed to assist new students with getting acclimated to the campus and college life.

Faculty/Staff Honors and Accomplishments

Queensborough Community College's A.S. in Public Health program has been selected as a 2017 recipient of the Riegelman Awards for Excellence in Public Health and Health Navigation Education in Community Colleges. Queensborough's Public Health Program will be recognized at the League for Innovation in the Community College Innovations Conference in San Francisco, CA in March. Dr. Anuradha Srivastava, Biological Sciences and Geology Department and Dr. Andrea Salis, OAA and Health Physical Education and Dance Department will represent the College during the general session and panel presentation.

General Education Task Force

During January a group of 15 task force and other faculty members scored 566 student artifacts, from 47 courses, submitted during the fall 2016 term. The artifacts were rated according to the rubrics for one or more of the college's first four General Education Outcomes, and the results were shared with Task Force members at the first meeting of the term, February 3. During spring 2017, the task force will developing a "digital technology" dimension for the Information Management rubric, and will convene groups of disciplinary faculty to begin developing rubrics for the discipline-specific General Education Outcomes. The call for student artifacts for the spring 2017 term has gone out, to be scored in June 2017.

Assessment Update

• Assessment Institute

As in past semesters, the Assessment Institute for QCC faculty is being held this spring semester over four successive Fridays—February 10, 17, and 24 and March 3—from 2:00 to 4:00 p.m. in the CETL computer lab. Conducted by Deans Arthur Corradetti and Kathleen Landy and Dr. Ian Beckford, the institute covers various kinds of assessment efforts on campus, with particular attention to course assessment. Since its inception in spring 2013, nearly one hundred thirty faculty members have participated in the institute.

Middle States

Over the next two and a half years, Queensborough Community College will undergo a self-study process in preparation for reaccreditation with the Middle States Commission on Higher Education (MSCHE). A call for volunteers to the entire campus community will be sent out in the coming weeks to serve on one of seven self-study working groups, each working group assigned to one of the seven MSCHE standards. Once formed in spring 2017, the self-study working groups will begin formal work in fall 2017, with a completion date at the end of the spring 2018 semester. Each working group will produce a chapter of the self-study report. After campus-wide review and discussion of the self-study report drafts in fall 2018, the full self-study report will be submitted to MSCHE in January 2019. The MSCHE site visit will take place later in spring 2019, with a final decision by the commission in June 2019. Participating in a self-study working group will be an opportunity to provide significant service to the college in a process that is central to the reaccreditation of the institution.

Mission and Goals

The Mission Review Committee has developed college goals in support of the new mission statement that was approved in spring 2016. The new college goals now come before the Senate for review and approval. If approved, the new college goals will provide the framework for the strategic plan that is being developed for next year and for the plans of subsequent years. Both "mission" and "goals" form the basis for standard 1 of MSCHE's "characteristics of excellence," one of seven standards with which colleges need to comply to be accredited.

BTECH Update

Effective February 6th BTECH will have a new Principal. Hoa Tu will be leaving to become an assistant superintendent for the NYC DOE. Patrice Henry will join BTTECH as acting interim principal. Over 70 students are enrolled in several college courses this semester and 10 students along with QCC technology students and faculty are attending a SAP Women in Data Science conference at SAPs new NY headquarters at Hudson Yards this February.

Center for Excellence in Teaching & Learning (CETL)

We are delighted to welcome Dr. Henry Davis, who has joined CETL as an Academic Program Specialist to support the High-Impact Practices. Prior to his appointment at QCC, Henry served in an administrative capacity with Fordham University's Graduate School of Social Service and as an Adjunct Professor with Fordham's Graduate School of Education. Hiring Dr. Davis is an important step toward institutionalizing the support of academic service-learning through regular tax levy funding and ensuring the organized and effective advancement of this valuable high-impact practice.

Facilities Update

During the Spring semester there will be a number of facility upgrade projects underway, including the following capital and college projects:

- The Medical Arts and Science Building roofs will be replaced under the long awaited Roof Replacement Project funded by New Year State and City Capital allocations. In the weeks to come, protective fencing will be installed around these buildings to ensure the safety of our students, faculty and staff. The Project is expected to last until June when work will begin on the Administration Building.
- The Science Atrium and Cafeteria Phase II planning is in final stages with work expected to begin in early 2018. During the planned second Phase, the Atrium with be enclosed with climate control for year round use. A new servery, with several food stations and other amenities, will be located in the same space as the current Science Cafe and will be supported by a new kitchen constructed in the Science basement.
- The Campus Electrical upgrade is progressing on schedule with most of the underground conduit completed. The work will continue throughout 2017 as the contractors focus on completing the new electrical sub-station on 56th Avenue.
- The parking lot #1 entrance on Cloverdale was widened to allow faculty and employees
 to enter in the mornings and evenings. The improved entrance was opened for the start of
 the Spring semester and has relieved congestion at the main gate typical at the start of
 classes.

On January 18, 2016, the Subcommittee on Food Insecurity of the Academic Senate voted unanimously to forward the following text, given below, to the Committee on Bylaws for their consideration:

Resolution for the Establishment of a Standing Committee on Food Insecurity at Queensborough Community College

Whereas, a growing body of research demonstrates that Food Insecurity is on the rise among students on college campuses, especially community college campuses, in the United States;

and

Whereas, this situation is particularly pronounced at CUNY, where a 2011 study showed that 39% of CUNY students were likely to experience conditions of food insecurity on a regular basis:

and

Whereas, local data, the finding of research conducted by Queensbough's Institutional Research office; Queensborough Faculty, and students, suggests that food insecurity across Queensborough's community is consistent with CUNY-wide conditions;

and

Whereas, in response to these conditions, the Academic Senate adopted a December, 2015 resolution, creating a Subcommittee on Food Insecurity that met regularly over the course of the 2016 calendar year, as documented in reports maintained on the college website for March; May; September; October; November; and December, 2016;

and

Whereas the report of this Subcommittee presented in March, 2016, advanced several recommendations that, in addition to supporting a partnership with Queensborough's Newman Center, on Cloverdale Boulevard, argued for both the need, and the feasibility, of establishing a food pantry at Queensborough Community College

and

Whereas, in response to these recommendations, President Diane Bova Call established a space on the fourth floor of the Library Building dedicated to the storage of non-perishable foods, that was named the Lucille A. Bova Food Pantry (in honor of President Call's late mother);

and

Whereas, the Lucille A. Bova Food Pantry opened in May, 2016, and, under the direction of four faculty members (Drs. Sharon Ellerton, Susan Jacobowitz, Amy Traver, and Subcommittee Chair Tai), conducted a successful pilot period during summer, 2016;

and

Whereas, on the basis of this pilot, the members of the Subcommittee on Food Insecurity, with the additional commitment of Professor Aviva Geismar, launched five weekly hours of operation for the Lucille A. Bova Food Pantry effective August, 2016;

and

Whereas, over the course of the fall, 2016, semester, supplies for the Lucille A. Bova Food Pantry were sustained by generous donations from Queensborough Faculty, students, and Administrators, as well as Food Drives that drew wide participation from various student clubs and honor societies across campus, as well as the Queensborough Student Association;

and

Whereas, drop-off points for these food drives on campus were also enhanced by fixtures (a rolling cart) donated by the faculty of Schmeller Library; and decorative elements supplied by Service-Learning students and faculty in the Department of Art and Design;

and

Whereas, the operation of the Lucille A. Bova Food Pantry also proved a valuable educational resource for additional groups of faculty and students in the Departments of Biology, Business, Social Science, and Health, Physical Education, and Dance, who all utilized the Pantry as a focal point for service-learning projects, culminating in a "Hunger Awareness Day" event conducted with the cooperation of Student Clubs and Honor Societies on November 23, 2016; and a day of student presentations, organized on December 8, 2016;

and

Whereas, the operation of the Lucille A. Bova Food Pantry was also facilitated, with the cooperation of Queensborough's Department of Marketing and Communications, by the establishment of a website, and an email address, available at: http://www.qcc.cuny.edu/FoodPantry/

and

Whereas, promoting and supply the Food Pantry has drawn upon the successful cooperation of multiple entities on campus, including and not limited to: Administrators, and administrative personnel and staff; full and adjunct faculty; Department chairs; student club members and advisors; members of Queensborough's Student Government; members of Queensborough's Student Government; and members of Queensborough's NYPIRG chapter;

Therefore Be It Resolved that the Academic Senate create a permanent Committee on Food Insecurity of the Academic Senate;

and

Be It Further Resolved that, to this end, the following language be forwarded to the Committee on Bylaws, as a proposed Amendment to Article VII of the Bylaws of the Academic Senate, *Committees:*

Section 23. The Committee on Food Insecurity Shall Consist of 11 members: 9 faculty members and 2 students: one officer of the Queensborough Student Association; and one other student.

The Committee on Food Insecurity shall:

- a. Maintain a Food Pantry during the academic year, for a minimum of four hours weekly;
- b. Establish any guidelines or parameters for the regulation of the Food Pantry as may be needed and appropriate;
- c. Promote partnerships with Queensborough Student Clubs, together with organizers of campus-wide events, to conduct Food Drives to supply the Food Pantry and raise awareness regarding food insecurity across campus;
- d. Promote partnerships with faculty and administration to explore service-learning and institutional advancement opportunities that support the Food Pantry as a means to contribute to the enhancement of student instruction, and address conditions of Food Insecurity within the Queensborough community.

and

Be It Finally Resolved that the operation of the Subcommittee on Food Insecurity of the Academic Senate will continue until the assembly of the standing committee membership is completed by the Committee on Committees as per Article VII, Section 8 of the Bylaws of the Academic Senate of Queensborough Community College

Rationale:

The problem of food insecurity on American college campuses commands a considerable literature of research, to which CUNY Faculty at the School of Public Health have made notable contributions (see references below). The establishment of Single Stop offices on several of the CUNY campuses (an initiative launched by former Vice-Chancellor Sanchez) was a critical step forward in addressing this problem at CUNY, which Chancellor J.B. Milliken has indicated he intends to expand in the coming years.

With the establishment of the Lucille A. Bova Food Pantry, in May, 2016, Queensborough Community College joined the ranks of colleges and community colleges across the country that have responded to the challenge of food insecurity by going one step beyond the establishment of a Single Stop referral service, in creating a point for food distribution on their campuses. The Lucille A. Bova Food Pantry makes Queensborough the fifth CUNY campus to take this important step, after Brooklyn College; Kingsborough Community College; Hostos Community College; and LaGuardia Community College, and offers a service to students equivalent to that offered at our closest geographical neighbor, Nassau Community College of the State University of New York.

As of this writing, generous donations from faculty, students, and staff have enabled the pantry to serve approximately 50-60 students per month with non-perishable take-away items. The operation of the Lucille A. Bova Food Pantry is, moreover, complemented by the availability of free, hot meals at the Newman Center, twenty hours weekly during the academic year (Monday-Thursday, noon to 4 P.M.).

The establishment of a permanent standing committee on Food Insecurity within the Academic Senate would facilitate the continuation of these services, and affirm that a commitment to addressing food insecurity on our campus as a holistic approach to implementing Queensborough's institutional mission had been formally incorporated into college policy. The establishment of a permanent standing committee of the Academic Senate would also facilitate grantsmanship on behalf of the food pantry, as well as continuing curricular development in various areas through service-learning and student and faculty research.
